Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after **three months** from the date of publication.

All Notices to be published in the weekly *Gazette* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 07th July, 2023 should reach Government Press on or before 12.00 noon on 23rd June, 2023.

PROPOSAL

By virtue of the powers vested in the Ipalogama Pradeshiya Sabha under Sub-section (1) of Section 134 of the Pradeshiya Sabha Act, No. 15 of 1987. I propose the declaration of the areas within the jurisdiction of the Ipalogama Pradeshiya Sabha, as described in the table below, as developed areas.

SCHEDULE

Starting from 50 feet from the end of the Thalawa-Kekirawa main road, extending from the Maha Iluppallama city boundary to Kottalbadhdha Sabha Jurisdiction, includes the first - class house situated on the right and left sides.

Starting from the Ranajayapura checkpoint, the housing block located to the left (SMA/KDE/IEL/ANP/DCE) Zone, lane 01 to lane 29, encompassing all houses within the designated zone.

Further I propose that the areas where houses are built within 100 feet on both sides of the road, located in Kalawewa, Hungawila, Theliyawa, Amunavettiya, Kusalaganama and Vijitapura city limits, should be declared as developed areas.
