APPROVING OF QUALIFIED GARAGES FOR THE ISSUANCE OF FITNESS CERTIFICATES YEAR - 2024

APPLICATIONS are invited from garage owners and depots belonging to the Sri Lanka Transport Board who are registered as a business and who can present evidence of relevant tax payments for the purpose of issuing certificates of fitness for the year 2024 for Commercial Vehicles registered in the Central Province. Only garages located in the Central Province will be considered for approval.

01. Applicants must meet the following qualifications :

(i) Facilities :

- (a) 20 feet long, 2 1/2 feet wide, 4 1/2 feet deep vehicle inspection pit or an inspection platform or lift providing similar facilities.
- (b) Brake testing equipment
- (c) Headlamp testing equipment
- (d) Mechanical tools such as wrenches, spanners, hammers etc. are used to check the undercarriage of the vehicle, steering joints, brakes, cables etc., and worn parts.

(ii) Staff :

As certification officers, persons with the following qualifications should be employed in the garage

- (a) Possessing five (5) years of experience in the field of Motor Vehicle Engineering with special specialization in Motor Vehicle Engineering or National Technical Diploma Certificate in Mechanical Engineering or Junior Industrial Officer Certificate.
- (b) Having passed the four (4) year Course in Motor Mechanics at Lanka German Institute of Technical Training Moratuwa or having eight (8) years of experience in the Field of motor vehicle engineering with other equivalent qualifications.

02. The following documents should be submitted along with the application form

- (a) Attested photocopy of certificated showing qualification of certifying officers.
- (b) A bank receipt received on crediting a non-refundable fee of Rs. 2,000 to the A/C No. 33965 (Bank of Ceylon) to the name of "Commissioner of Transport, Central Province".
- (c) A rough map showing the exact location of the garage and the route from the city center to the location (briefly detailed) as accessible to the inspecting officer. (Summary of the road map).

03. While issuing permits a smart phone is required to upload the details and photos of the tests conducted through the application software for the purpose of issuing revenue licenses through the eRL 2.0 program. Therefore, from year 2024, having a smart phone will be considered a mandatory part of garage registration for issuance of certificate of fitness.

The relevant applications are available from this office on working days of the week.

The cover containing the application should be marked "Registration of Garages for Issuance of Fitness Certificates 2024" on the top left corner of the envelope and send by Registered Post addressed to the Commissioner of Transport, Department of Transport, Central Province, Yatinuwara Street, Kandy to be received on or before **10th October, 2023**. Any application received after that date will not be considered.

PROVINCIAL PUBLIC SERVICE COMMISSION - WESTERN PROVINCE

Competitive Examination for the recruitment of Graduates to the Grade I (a) in Class 3 of Sri Lanka Teachers' Service for Sinhala, Tamil and English Medium Vacancies in Western Provincial Schools - 2023 (Stage II)

APPLICATIONS are called from the eligible graduates permanently residing in the Western Province and who fulfill qualifications according to this notification to be recruited to Grade 1 (a) in Class 3 of Sri Lanka Teachers' Service complying to Sri Lanka Teachers' Service Minute of the Public Service of Western Province for the vacancies in Sri Lanka Teachers' Service existing in the schools of Western Provincial Council.

01. Recruitments will be made for Sinhala, Tamil and English medium vacancies on provincial basis and number of recruitments will be decided based on the existing provisions and the service requirement. This examination is valid for vacancies exist until **31.12.2025**, subject to the further approvals for recruitments. Recruitments will be made on the priority order of total marks obtained by the applicants at the competitive examination and the practical examination.
02. **Salary Scale :**
Monthly salary scale applicable for this post will be Rs.31,490 – 6×445– 7×525– 2×600–39,035/- as per the salary category of GE-01-2016-a in terms of Public Administration Circular No. 03/2016 (iv). You will be placed in the 14th step, *i.e.*, at Rs.37,835/- of this Salary Scale.

03. Educational and Other Qualifications :

3.1 Educational Qualifications:

i. Should have obtained a degree related to the subjects specified in the schedule 01 awarded from a university recognized by the University Grants Commission or from a degree-awarding institution recognized by the University Grants Commission in a field specializing in and recognized for the purpose of teaching. This degree should be valid prior to the closing date of the applications.

and

ii. Should have passed six (06) subjects with three Credit Passes including passes for the subjects of Sinhala Language and Mathematics in not more than two attempts at the General Certificate of Education (Ordinary Level) Examination. (Shall have passed in at least 05 subjects in one sitting.)

and

iii. Should have passed the General Certificate of Education (Advanced Level) Examination in 03 subjects at one sitting.

Very Important (Should be considered when filling the applications)

- Applicants should be aware of the subjects they can apply for as per their degrees.
- Can apply for the relevant teacher vacancies based on the main subject/ subjects studied for the degree
- Can apply for only three subjects
- Will not be allowed to change the applied subjects and medium due to any reason later

3.2 Physical and Mental Eligibility:

Every candidate should be mentally and physically fit to perform duties as a teacher.

3.3 Age:

Should not be less than 18 years and more than 35 years of age as at the closing date of applications.

3.4 Other Qualifications:

- i. The applicant should be a citizen of Sri Lanka,
- ii. The applicant should be of excellent character,
- iii. Should be able to serve in any area of the Western Province,
- iv. Applicant or the spouse should be permanent residents of Western Province for a period of not less than 03 years preceding immediately to the closing date of applications. (Should confirm at the interviews by the Certificate on Residence [DS 04 format] issued by the Grama Niladhari).

04. Service Conditions :

- i. Selected Graduate candidates will be appointed to Grade 1(a) in Class 3 of the Sri Lanka Teachers' Service subjected to the general conditions governing Public/ Provincial Public Service appointments, the conditions imposed by the Sri Lanka Teachers' Service Minute of the Western Provincial Council Public Service and any amendments already made to such minutes or will be made thereafter.
- ii. This post is permanent and pensionable. Appointees should comply with the policy decisions taken by the Government in future regarding the pension scheme.
- iii. Candidates appointed to this post will be subjected to a probationary period of 03 years.

- iv. Promotions will be made according to the Teachers' Service Minute of the Western Provincial Council Public Service.
- v. Should acquire proficiency in the Second Language as specified by P.A.C. 18/2020 dated 16.10.2020 and amendments made to it from time to time.

05. Recruitment :

5.1 Method of Recruitment:

Recruitments will be made according to Section 7.2.4 of Sri Lanka Teachers' Service Minute of Western Provincial Council Public Service which is effective from 01.07.2008.

A written examination will be held for the selection.

According to the order of highest marks received at the written examination, a three-fold number of applicants compared to the vacancies existing for each subject within the province will be called for the general interview. Applicants who qualify from the general interview will be called for the practical test later.

Applicants, who obtained the highest total marks at the written examination and practical test will be selected for the existing vacancies as enforced by Section 7.2.4.3.1 of Teachers' Service Minute.

Recruitment period based on the results of this examination according to this *Gazette* notification will be valid for the vacancies existing as at 30.06.2023.

5.2 Written Competitive Examination: consists of two papers

Syllabus :

Subject No. 01 – Aptitude Test

This question paper is designed to measure the candidate's skills relating to the teaching profession and knowledge of logical intelligence. This consists of 50 multiple choice and short answer type questions. All of those questions should be answered.

Subject No. 02 – General Knowledge

This paper consists of multiple choice and short answer type questions that test general knowledge on field of teaching and/or general knowledge on trends in educational developments that have taken place/are taking place locally and general knowledge on educational modernization. All those questions must be answered.

5.3 Examination Procedure :

- i. This examination will be conducted in Sinhala, Tamil and English mediums.
- ii. Every applicant should face all the papers of the examination in one language. That language medium should be the same language medium for the appointment.

- iii. No applicant will be allowed to change the language medium of his/her application later.
- iv. Every applicant should sit for both (02) papers.
- v. Number of recruitments made at a time will be decided by the Appointing Authority.

5.4 *General Interview :*

Examining the physical qualifications and whether the applicant has fulfilled the qualifications stated in the notification published in the *Gazette* or newspaper advertisement or website in accordance to the Service Minute.

5.5 *Practical Test :*

Practical test consists of a presentation by the applicant under a topic selected by him/her. Marks will be given as below.

5.6 *Method of the Practical Test :*

- (i) Not more than five (05) minutes will be provided for the practical test.
- (ii) Maximum marks that can be obtained for the practical test is twenty five (25) marks.
- (iii) A minimum of 02 marks each should be obtained for each of the criteria to pass the practical test.
- (iv) The practical examination will be evaluated by an interview board appointed by the Western Provincial Public Service Commission.

5.7 *Objectives of the Criteria :*

- (i) Objective and approach

Evaluating the ability to explain the objectives of the lesson successfully and the ability to approach the lesson.

- (ii) Personality and voice control

Evaluating whether the applicant has a good personality fit for a teacher and the ability to control the voice properly while teaching.

- (iii) Clarity of communication

Evaluating the ability to effectively communicate relevant issues in the teaching- learning process.

(iv) Time Management

Evaluating the ability to reach the goal within the given period of time

(v) Use of presentation techniques

Evaluating the ability to make good use of presentation techniques to reach the goal.

06. Examination Fees :

A sum of Rs. 1200/- should be paid to any Divisional Secretariat within the Western Province to be credited to the Western Provincial Revenue Head 20-03-02-99 and the receipt **W.P.-01** obtained thereof in the applicant's name should be affixed firmly on the due place in the application.

It should be considered that any other receipts obtained by paying money to other institutions and money orders or money **will not be accepted** except the receipt of **W.P.-01** format, applicants who submit such receipts will not be allowed to sit for the examination. It should also be taken into consideration that the examinations fees paid will not be refunded on any reason, nor shall such fees will be exchanged for any other examination. (A photocopy of the receipt obtained after paying money should be kept in possession for future reference).

07. Method of Application :

- i. All the candidates, after paying the prescribed examination fees shall access our official website www.psc.wv.gpv.lk and by entering the relevant information in the Application form therein and submitting the same, can download the application. Schedule 01 referred herewith shall be used in filling the application.
- ii. Applications, that have been applied online yet not downloaded and applications that have been prepared and printed by computer will be rejected without any notice.
- iii. Incomplete applications and applications sent without fulfilling the basic qualifications will be rejected without any notice. It would be useful to keep a photocopy of the completed application in applicant's possession.
- iv. Subjects and the order of preference applied for shall not be changed later on any grounds and one applicant can submit only one application.

No certificate should be attached to the application. Only the original receipt obtained by paying the fee should be affixed (not attached).

v. Attestation of the Signature of the Applicant:

Applicant's signature should be attested by a person authorized to attest the application and the admission paper for the examination. The signature of the applicant should be attested by a Principal of a Government School, Justice of Peace, Commissioner of Oaths, Attorney-at-Law, Notary Public, Commissioned Officer of Three Forces, Officer of the Police Service holding a Gazetted position, an Officer of Government or Provincial Public Service in a permanent Staff Grade position drawing an annual basic salary of Rs. 498,960/- or above, Chief Incumbent or Chief Priest of a Buddhist temple or a member of the Clergy holding a considerable status.

Signatures of applicants who are already serving in the Provincial Public Service of Western Province should be attested by the relevant Head of the Department or by an officer authorized to attest on his behalf and the application should be submitted through the Head of the Department.

08. No complaint regarding applications lost or delayed in the post will be accepted and delayed applications will not be considered on any grounds.
09. Western Provincial Council Public Service Commission has the final decision regarding any matter undisclosed by this notification including the matters pertaining to postponing or cancellation of this examination, selection/non-selection after conducting the examination or final decision regarding the number of vacancies to be filled.
10. Receipt of applications will not be notified. As soon as the admissions are issued to the applicants an announcement will be made about it in the official website of the Western Provincial Public Service Commission, i.e., www.psc.wp.gov.lk. If the admission was not received even after 7 days of the publication of the notice, the applicant should inform the Western Provincial Public Service Commission as stated in the notification. The applicant should make his/her inquiry from the Examinations Unit of the Western Provincial Public Service Commission while keeping a copy of the application, payment receipt, receipt of the Registered Post ready in his/her hand and giving his/her full name, address, NIC number and name of the examination correctly.
11. On the presumption that only the eligible persons have applied and paid the prescribed examination fee and have properly submitted the online applications and forwarded the printed copy along with the respective receipt on or before the closing date of applications, the admissions will be issued for the applicants. The issuance of an admission to an applicant for the examination is not considered as an acceptance that he or she has fulfilled the qualification to sit the examination or to hold a post. Merely passing the examination will not be considered as a qualification to get the appointment. In any occasion where it is revealed that the applicant has not fulfilled the qualifications, the Western Provincial Public Service Commission retains the right to cancel the applicants' candidacy for the examination and reject the awarding of the appointment.
12. If any inconsistency between the Sinhala, Tamil and English texts of this announcement should arise, the Sinhala text shall prevail.
13. Duty should be assumed within 14 days of the date of appointment mentioned in the appointment letter and if the applicant fails to do so, the appointment will be annulled without any further notice.
