IN terms of the powers conferred on the local councils under sub-section (1) of section 134 of the Local Council Act, No.15 of 1987, under decision No. (e) 15 dated 10.09.2019 by Kirinda Puhulwella Pradeshiya Sabha, it is hereby announced to the public that the following proposal standards regarding the declaration of developed areas have been approved under the powers vested in me as per the above section.

PROPOSAL

In terms of the powers conferred on local councils by sub - section (1) of section 134 of the Local Council Act, No. 15 of 1987, whether situated within the jurisdiction of Kirinda Puhulwella Local Council, or situated within the boundaries described in the map included in the following schedule, Kirinda Puhulwella Pradeshiya Sabha suggests that under sub-section (1) of section 134 of the said Act which should be read with No. 12 of 1989 (Ancillary Provisions) Act section 2, the approval of the Minister in charge of Local Government should be requested to declare the area as a developed area, to get the approval of the Assistant Commissioner of Local Government of Matara District for this proposal and to assess the annual values of all immovable properties and types of immovable properties located in that area, and to order assessment based on the annual values assessed.



Boundaries of the area proposed to be declared as a developed area of a perrimeter of 15 kilometers and 2.71 square kilometers situated within the jurisdiction of Kirinda Puhulwella Pradeshiya Sabha in Matara District, Southern Province;

- A. Starting from Kirinda Kamburupitiya Road junction and to Matara Road South School Junction (1.2km) to the junction where the Kamburupitiya Road starts at the end of school lane of the southern part (1.3km), from Kirinda Kamburupitiya Junction to School Junction (1.1km) where Kamburupitiya Road separates from the fields and land,
- B. Starting from Kirinda Kamburupitiya Road junction, 1km Kamburupitiya Road south Buddhajayanti Mawatha, the area to the boundary canal within 400m of Buddhajayanti Mawatha and Hakmana road left post 13 (0.7km) from Kamburupitiya Road junction and the area bounded from the canal from 200m of Galkanda road.
- C. Starting from Kirinda Kamburupitiya Road junction, Hakmana Road South to Mahahena Road junction (1.4km) and ending at the junction at the crossing at the end of 200m on Mahahena Road, the land area separated from paddy field and starting from Kirinda Hakmana Road Dhammananda Mawatha junction and ending at Beliatta Road junction on that road. (2.2km) land area bordered by paddy fields. Again, the land area separated from paddy fields up to (2.1km) Dhammananda Mawatha junction on the left side of Gatamanna Road,
- D. Area separated from paddy fields and land upto Suwanda Kakuna lake road (0.7km) starting from Gatamanna road junction in Hakmana road and from Gatamanna road Suwanda Kakuna road to Sarananda road junction (0.4km), to Puwakgaha madiththa road junction at the end of Sarananda Road and the southern part of Sarananda road and Suwanda Kakuna lake road, again to Wadugedara road junction 0.5km along Puwakgaha Madiththa road upto Puwakgaha Madiththa Road Junction ,0.6km at the end of Wadugedara 11 post road to Hakmana road junction the area separated from gardens and commercial crops on the right, the left area from Hakmana road to Illukhena road junction (1.1km).
- E. The area between Matara road South school road junction and the end of the Sabha boundary within 200m of the road separated from the land and the canal.(1.20km).
