All Notices to be published in the weekly *Gazette* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 26th July, 2024 should reach Government Press on or before 12.00 noon on 12th July, 2024.

## KARAICHI PRADESHIYA SABHA
