#### REGISTRATION OF RECOGNIZED MOTOR GARAGES FOR THE ISSUANCE OF FITNESS CERTIFICATES - YEAR 2025

APPLICATIONS are invited from the Garage owners who can produce evidences that they are registered their business and pay business turn over tax, and from the depots of Sri Lanka Transport Board, to issue fitness certificates for commercial motor vehicles registered within the Central Province. Applications are invited only from the garages located within the Central Province.

1. Applicants shall have fulfilled following requirements :

#### I. Facilities

- 1.1 20 feet long, 2 1/2 feet wide and 4 1/2 feet deep vehicle inspection pit or an inspection platform or a lift providing similar facilities.
- 1.2 Brake testing equipment
- 1.3 Headlamp testing equipment
- 1.4 Mechanical tools such as wrenches, spanners, hammers etc., are used to check the undercarriage of the vehicle, steering joints, brakes, cables etc., and worn parts.

#### II. Staff

The Certifying Officers with the following qualifications should be employed in the garage

- II.1 Shall have possessed a Special Proficiency in Motor Vehicle Engineering or National Technological Diploma in Mechanical Engineering or Junior Technical Officers' Certificate in Mechanical Engineering with five (05) years of experience in the field of motor vehicle engineering.
- II.2 Shall have passed the four (04) year course in motor mechanics at Moratuwa Ceylon German Technical Training Institute or any other equivalent qualifications with eight (08) years of experience in the field of motor vehicle engineering.

2. Following documents must be furnished with the applications

- 2.1 Attested copies of the certificates confirming the qualifications of the certifying officers.
- 2.2 A bank receipt for a sum of Rs. 2,000 credited to the Bank of Ceylon, **Account No. 33965** in the name of "Commissioner of Transport, Central Province", as a non-refundable deposit.
- 2.3 A rough sketch showing the exact locaiton of the garage and the road access from the center of the city as accessible to the inspecting officer (Brief details on road map)

3. Having a smart phone is necessary as details and photos of the tests to be uploaded in applicaiton software as to issue vehicle revenue licenses under eRL. 2.0 program launched to issue vehicle revenue licenses. Therefore, having a smart phone will be considered a mandatory part of a garage for regisration of motor garages to issue fitness certificates in the year 2025.

Duly perfected applications should be posted under registered cover, to reach “the Commissioner of Transport, Department of Transport, No. 104, Yatinuwara Street, Kandy” on or before **15th October, 2024**. The caption “**Registration of Garages for the issuance of Fitness Certificates - Year 2025**” should be indicated on the top left hand corner of the envelope enclosing the application. Applications received after due date will not be considered for any course.
